I. Welcome/Introduction & Question

a. Your name, organization; When was the last time you used public transit? Where and for what purpose?

II. Align: The Rapid's Transit Improvement Study: Max & Conrad

The purpose of the Align Study is to identify, analyze, and prioritize the transit system. The project is currently in phase 1, which is to decide what to do with the existing service and what the new service will look like. They are currently about 1/3 of the way through the project schedule of transitioning to the new system. Phase 1: Identify corridors and projects (April – September) Phase 2: Evaluate and Prioritize (September – November) Public outreach and online interaction, which includes platform events and speaker series, these events will include translators and interpreters. Phase 3: Announcing to the public. Select corridors and projects. In Grand Rapids, there is job growth and population growth but there is a disconnect between these areas and this is a challenge for the transit system.

A public feedback tool is already integrated into the site.

There was interest in learning about employers subsidizing bus fare or covering it entirely, for example with Spectrum Health.

About 84 percent of the time the buses are within 5 minutes of their stop time.

There is a renewal millage vote this November and if it's not passed there would be a loss of upwards of 50% of services. The align transit study is not aligned with the millage renewal in any way.

III. Complete Collaborative Failure Exercise

Important to encourage accountability, productivity, & proactivity. We'll work together to identify and define positive behaviors.

Elements of collaborative failure that have been identified as group are: lack of buy-in, time, ineffective communication, capacity, lack of clarity, action team dynamics. Each group will address these elements today and discuss.
