Equity Reflection:

Discussion

Last month, the Equity Action Team encouraged folks to attend a J-Series presentation. This month, the group broke into rooms to reflect on the presentations. Reflections/takeaways:

- Discussed faith, complicity, and silence
- Discussed lack of civic engagement and the low amount spent per child on civics education.
 (report)
- We have power in shaping a narrative; must be intentional in shaping the narrative with our values. Consider:
 - What are the narratives communicated by your organization?
 - O Who contributes to the creation of those narratives?
 - Would you talk *with* the population you serve how you talk *about* them with donors, board members
- Capitalism and West MI long-standing pride in frugality has led to depression in wages; exploitation is inherent in capitalism. Action steps include advocacy around tax reform and calling out structures in which folks are seen as disposable.

System Scan Presentation

Discussion

Jodi, from Petersen Research Consultants, looked at updating the mapping of zones from the data decision tree work and identified new ways of clustering census tracts that are most similar based on demographics and economic need. Clusters are not geographically contiguous. Strong indicators for similarity were race and ethnic makeup, unemployment rate, single parent households, and education. The hope to use this data and overlay service analysis data. They also want to ensure that all have the access to data that is helpful to their organization. Questions/Reflections:

- Jodi looked at disability status and found it was not a differentiator. But it can be included on the data tool.
- Suggestion to add neighborhood information to help geographically identify areas.
- Suggestions to added employment clusters and industry. Could also include data on commute times as many folks do not work where they live and look at where jobs were lost. (<u>link</u>)
- Cedar Springs and Wyoming areas are in the same cluster. They are not demographically similar, but workforce development needs are similar in both.
- Conversation around including an original nations category. This is difficult with current census data, but can be done with locally-collected data. There is also opportunity to advocate for national-level changes in decolonizing data collection.
- Think about the stories we tell ourselves when we look at data like this would it be helpful to have someone from the data team help craft language around why there is concentration of poverty in certain areas.

Thanks to Jodi and team for all their work on this project. Will be using this data and considerations combined with service analysis results to have zone level conversations.
